About the Exhibition

Rise Up, Fallen Angel is an Integrated Media Performance that will involve live improvised music accompanying images projected on three large screens. The curator will group the images so they will be displayed to create a non-linear narrative relating to the theme.

The exhibition will be different each time it is shown, but documentation of the event will be available for viewing. We are seeking images and video that do not contain text or language, but connect with the viewer on a primal, emotional level.

About the Theme

The purpose of the exhibition is to create an organically resonant, sensory immersion that satisfies the need for spiritual renewal and tribal ritual in a contemporary context. We seek to reinforce the resilience of the human spirit: to rise up and overcome the problems we all recognize in our lives, our communities and our planet. Rise up, fallen angel; renew your divine grace and live with love.

The interpretation of the terms "angel", "divine grace", "love", "human spirit" and what it means to be a "fallen angel" are open to interpretation by the submitting artist. Returning to the primal commonalities of human animal needs and core desires this work is intended to cross cultural boundaries so there will be no text or language in the work.

Terms of Participation

- 1. There is no fee to participate.
- 2. Each artist will receive attribution in the on-line and pdf download catalogue.
- 3. Please submit visual or audio work in an electronic format. Acceptable formats listed below.
- 4. Participating artists agree that their visual work will be viewed though projection on a screen in conjunction with other works as arranged by the curator. Audio work submitted will be built upon by the live improvising musicians. All works will be arranged and integrated by the curator into a larger piece called *Rise Up, Fallen Angel*.
- 5. The Creative Commons Attribution 3.0 license will be used as a recognized standard definition of rights granted for the non-exclusive use of works submitted, that are used in the exhibition. All works will retain the original artist copyright outside of uses detailed in Item 6.*
- 6. Accepted works will be used in the exhibition, *Rise Up, Fallen Angel*, the companion catalogue and promotional, marketing or advertising materials related to the exhibit.
- 7. Contributing artists agree that all works accepted become a permanent part of the exhibition, *Rise Up Fallen Angel*, a new integrated media work that may be exhibited in future by

- arrangement with the curator.
- 8. Exhibitions of the new integrated media work, *Rise Up Fallen Angel*, will be documented in photographs and video that may be posted or streamed on the internet, copied on DVD or otherwise distributed.
- 9. Participating artists release Victoria Gibson, VIX Productions and its agents, principals, employees or servants from any liability regarding the display of work that you have submitted to them, including any liability for redisplay by individuals making copies of the display or advertising.
- 10. No identifiable language will be used either in visual or audio formats.**

** Working without language is a freedom and a constraint. Text is a precise method of conveying meaning, but it limits the audience to those who understand the language and the cultural frame of reference. This work is a free-flowing stream that challenges artists to transcend language and speak more directly to the human spirit.

How to Submit Your Work

Work will be displayed on large projection screens, so high resolution images are required.

Images: tif, tiff, jpg, png, 300 dpi resolution minimum – highest possible preferred

Maximum length for video 20 minutes.

Video: mov, MP4, standard and high definition accepted
